South Charleston to Host the 62nd West Virginia State Championships

This Labor Day weekend, the Charleston Chess Club will host the 2000 West Virginia State Championship which will be held at the Hampton Inn - Southridge Center in South Charleston, WV. Mark Hathaway and Donald Griffith look to defend their piece of the championship.

The weekend's events will begin with the WVCA Business Meeting at 10am. We will surely be discussing the revision of the WVCA Constitution. Also, on the agenda are the election of officers and the vote on where next year's tourney will be.

Round one of the tourney gets underway at 12:30pm on Saturday. Two rounds of chess a day at time controls 40/90, G/1. The Blitz Chess Championship, (WBCA rated) will be held on Saturday night, time to be announced at the site. The Quick Chess (G/10) Championship is scheduled for Sunday night. Lots of time for skittles, bughouse, post-mortems and all the other tourney activities you could hope for.

Make your hotel reservations early as the Sternwheel Regatta festival will be ongoing in Charleston over Labor Day weekend. Most of the hotels in the area tend to fill up quickly. See page two for more details.

Some interesting statistics from the State Championship:

- Most state Championships won are by Dr. Siegfried Werthammer (Huntington), who won (or shared) 13 titles between 1943 and 1965. From 1943 to 1953, Dr. Werthammer had a stake in 9 of the 11 Championships.
- Donald Griffith is second with 10 State Titles.
 He won his first Championship in 1975.
- The last time the State Championship was held in South Charleston was 1948. It was held at the

Recreation Hall.

- The WV State Tourney was held in Ohio in 1986. Organizer Randy Bierce had made all the arrangements for the tourney to be held in the Wheeling area, but a steel (or coal) strike occured. The hotel hosted the negotiations; needless to say, he had to find a new site. The only available site at the late date was in St. Clairsville, OH.
- The most players entered in the State
 Championship was 66 at the 1996 Parkersburg
 events breaking the record of 65 set in
 Charleston in 1974. Clarksburg (1981) and
 Athens (1972) each had 62 participants.

West Virginians at the 2000 World Open

Four WV players traveled to Philadelphia to compete in this year's World Open: John Roush, Gary Cummings, Scott Carmichael and Sefus Ellis. John entered the Open Section and finished with a score of 4 out of 9. He won only one game (over Jerry Hanken), *drew six*, and lost two. Most of the draws were to master strength competitors. John's rating is now back over 2100. Gary, Scott and Sefus all entered in the Under 1800 section. Gary fared the best, tying for 11th place (probably just out of the money) with a score of 6½. Sefus finished with a 5½ score and gained about 75 points. Scott lost his first two games, withdrew and then re-entered with byes in the first two rounds. He finished with a mark of 4½.

John Wright at the U.S. Open

Charleston Club member John Wright is currently at the 2000 U. S. Open which is taking place in Minneapolis, Minnesota. He is entered in the Matinee section and has so far scored 2 out of 5. Best of luck to John.

Proposed Revision of the WVCA Constitution

Here is the proposed revision of the WVCA Constitution that was worked on for the past year by a committee that included: John Homer, Jim Olson, John Roush, Tom Bergquist and myself. Please read this and have questions and comments ready for the WVCA Business Meeting as this will be on the agenda. If you cannot make it to the meeting, please feel free to contact me at: tlabue@msys.net or any of the other committee members. There are many changes to the Constitution including instituting a seven member Board of Directors, separating the WVCA bylaws from the rest of the constitution, and some new wrinkles for the Grand Prix. Hopefully, we have addressed most of the big holes that the constitution had before.

WVCA Constitution

(August 8, 2000 Revision)

ARTICLE I: NAME

The name of this organization shall be the West Virginia Chess Association, known as the WVCA and incorporated under the laws of West Virginia as a non-profit corporation.

ARTICLE II: PURPOSE

Its purpose shall be to promote acquaintance, understanding, and fellowship among chess players of West Virginia. It will also conduct state Chess Championships as well as any other chess events the membership of the Board of Governors select. It shall put out a Bulletin at least twice a year.

ARTICLE III: MEMBERSHIP AND MEETINGS

Section 1. Membership shall consist of all interested in the game of chess.

Section 2. There shall be the following classes of membership:

- a. Honorary Life Members No dues, full voting privileges.
- b. Regular: one year, full voting privileges
- c. Life Membership: full voting privileges, unending membership
- Section 3. Membership dues are payable in advance. Membership may begin at any time during the Fiscal Year.
- Section 4. The Fiscal year shall begin on September 1st and end on August 31st.
- Section 5. Residence outside the state is not a bar to membership; however, it is a bar to holding the title of State Champion. Military personnel and college students who are home on annual leave or summer vacation are eligible for the title so long as prior to their enlistment or enrollment they were residents of the state.
- Section 6. There shall be an annual business meeting held, preferably during the State Championship, for the purpose of electing officers and transacting association business. Members are entitled to vote in person. An option of voting through the WVCA Bulletin is available during the year when it is not practical to convene a business meeting. This can be done at the discretion of the Board of Directors.

Section 7. The quorum for the annual business meeting shall be 10 per cent of the current membership.

ARTICLE IV: OFFICERS AND OTHER POSITIONS

Section 1. Officers of this association shall be the President, Vice-President, Secretary-Treasurer, Bulletin Editor, Webmaster, USCF Delegate and an at-large member duly elected at the annual business meeting. All terms are for one year with the exception of the Treasurer who retains office for 3 years.

- Section 2. Only active WVCA members over the age of 17 shall be eligible to hold office or Board memberships. Committee positions can be filled any active member with no requirement on age.
- Section 3. The President shall preside at all business meetings. He will appoint committees. He will act as chairman during any meeting of the Board of Directors. He will call special meetings as need arises according to the procedures contained within.
- Section 4. The Vice-President shall preside in the absence of the President or act as his designate when requested of him. Shall assume the office if the President if the President resigns or dies, is removed from office for misconduct, or is prevented from executing the duties of that office as a result of disability.

Section 5. The Secretary-Treasurer:

- a. Shall collect the dues and monies owed the association. He will pay all accounts of indebtedness that have been certified for payment by the other board members or himself. He will submit a financial report of the association at the annual business meeting on Labor Day weekend for the fiscal year that just ended August 31st.
- b. Shall keep on file, the minutes of the association's business meetings.
- c. Shall record minutes of all meetings (Business, Board, and Special).
- d. Shall handle correspondence for the association.

Section 6. The Bulletin Editor:

- a. Shall be responsible for publishing the WVCA Bulletin at least twice a year.
- b. Shall publish the Bulletin through private enterprise or donated printing services.
- c. Shall keep a record of the Constitution, and amendit-as so ordered by the membership.
- d. Shall work closely with the archivist and the Webmaster.

Section 7. The Webmaster:

- a. Shall be responsible for the upkeep and maintenance of the WVCA
- Website, which included continued registration of the WVCA domain name: wvchess.org.
- b. Shall work closely with the Bulletin Editor.
- Section 8. The USCF Delegate shall try to attend the USCF Delegate meeting which is held during the U. S. Open in August. He shall keep the association informed as to new and ongoing developments at the USCF.
- Section 9. The same person may perform the offices of Bulletin Editor and Webmaster. If this happens, this individual will have only one vote on the board and a second at-large member shall be elected by the membership to fill the final slot on the board.
- Section 10. The membership will elect Voting Members to the USCF. The number for representatives will be determined by the USCF. Any member age 18 and over is eligible to become Voting Member. A Voting Members duties are to vote in USCF elections. Voting members votes should be distributed to the Secretary-Treasurer so that they may be made public to the WVCA Membership through its media outlets.
- Section 11. There are a few positions that shall be selected by the board. These positions shall be WVCA Archivist, Grand Prix Coordinator and the Postal Director. These positions can be held by any active member, elected officers not excluded.
- a. The archivist shall keep the WVCA archives, which includes almost all of the WVCA Bulletins, photos and other publications. The archivist shall work closely with the Bulletin Editor and Webmaster as to help disseminate some of the

historic information contained within. This position length should be for an indefinite period of time.

- b. The Grand Prix Coordinator will run the West Virginia Grand Prix cycle. The Coordinator will designate Grand Prix events according to the guidelines set in Appendix X and tabulate points accordingly. The Coordinator will be responsible for the prize allocation. This position should be for a full cycle of the Grand Prix.
- c. The Postal Director will organize and direct the West Virginia State Correspondence Championship every two years. The Postal Director will also have the option of organizing other postal tournament and e-mail events as desired. The Postal Director must possess at the minimum a USCF Club Tournament Director certification status in good standing. The term for this office is two years.

ARTICLE V: BOARD OF DIRECTORS

Section 1. The Board of Directors shall consist of the President, Vice-President, Secretary-Treasurer, Postal Director, Bulletin Editor, Webmaster and the USCF Delegate.

Section 2. The Board of Directors shall be charged with the responsibility of running the association meetings. In addition, the Board of Directors shall have authority to:

- a. Act on issues concerning the WVCA. If an issue comes before the Board, in lieu of consensus among the members, a vote shall be taken. The results of the vote are to be given to the Secretary-Treasurer, who will record them and then submit them to the Bulletin Editor and Webmaster for publication.
- b. Purchase any items it deems necessary if the value of the items does not exceed \$25. Purchase of any items above this limit would require membership approval at a business meeting. The (1) printing and postage cost of the bulletin and (2) sponsorship of the State Championship and the WVCA Grand Prix are the only two exceptions to this prohibition.
- c. Warn, suspend, or expel any member for conduct unbecoming a member or harmful to the purposes of the Association. No member may be expelled except by affirmative vote of two-thirds of the members of the Board of Directors present at a special meeting. Before any member is suspended or expelled, written notice of the charges against him, and of the time and place of the meeting of the board at which they are to be considered, shall be mailed to him at his last known address at least twenty days before the meeting. He shall be given an opportunity to defend and the decision of the Board shall be final.
- d. Removal of any officer with a two-third vote of the Board of Directors.

This shall be done in accordance with provision (c).

e. Perform any and all other acts necessary for the operation of the WVCA not specifically denied by this Constitution and its Bylawsia

ARTICLE VI: RULES

All applicable United States Chess Federation (USCF) or World Blitz Chess Association (WCBA) rules and current laws of chess shall govern the play at all WVCA tournaments and the issuing of prizes.

ARTICLE VII: AMENDMENTS

Section 1. The Constitution may be amended by a two-thirds vote by the membership at the annual business meeting over Labor Day weekend. There must be enough members to satisfy a quorum present in order to amend the Constitution.

Section 2. The Bylaws may be amended by the following procedure:

- a. A proposed change should be send to the President by July 1.
- b. The President will distribute all proposals to all board members by mail or electronic mail.
- c. The bulletin editor and Webmaster will post the proposed changes in their respective media. The aim is to inform the membership of the new proposals before the business meeting. Comments can be made to the Board about the proposals.
- d. An amendment to the Bylaws must be approved by a majority of the membership at the annual business meeting of the WVCA.

e. There must be enough members to satisfy a quorum present in order to amend the bylaws.

ARTICLE VIII: TRUSTEES

Two trustees are to be elected who will be authorized to sign checks and withdraw funds from WVCA accounts in emergency situations. The term of each trustee is five years. If a trustee must vacate his position before his term expires, a new trustee shall be elected for the rest of the unexpired term at the next business meeting.

ARTICLE IX: SPECIAL MEETINGS

Section 1. Special meetings of the WVCA Board may be called by the President as the need arises with the written agreement of at least two other members of the Board of Directors. All members of the Board of Directors must be notified of the time and place of the meeting in writing at least one week prior to the meeting. The notice of the meeting will clearly set out an agenda for the meeting. No action will be taken at the said meeting that is not related to an idea on said agenda.

Section 2. The Secretary-Treasurer shall take Minutes at all meetings. Copies of the minutes shall be furnished to Bulletin Editor and the Webmaster for public distribution to the membership of the organization.

WVCA Bylaws

The purpose of these Bylaws shall be to define specific policies governing the operation of the West Virginia Chess Association (WVCA) and the tournaments sponsored by the WVCA.

- 1. The meetings of the Board of Directors of the WVCA shall be open to all members of the club. These attending members shall have the right to taking the floor but may not vote.
- 2. The fee for a Regular membership to the WVCA is \$7 for one year. The cost of a Life membership is \$140.
- 3. Annual State Chess Championship conditions of contest:
- a. The annual State Championship shall be contested over Labor Day weekend.
- b. The tournament shall be a six round Swiss system event with two rounds each day. There will be one section, open to all players.
- c. The time control for the annual State Championship shall be conducted at forty (40) moves in ninety (90) minutes, with (SD/1) sudden death in an hour.
- d. The TD has the discretion to designate how to break ties.
- e. The organizers of the State Championship are allowed to specify the entry fees.
- f. Any WVCA member is eligible to win a class trophy, regardless of residency.
- g. The local organization that is chosen to host the State Championship shall submit all details to WVCA officers four months prior to the latest time the announcements must be in to the USCF. A written contract with the site must be in existence. If this is not done, the President shall have the responsibility and financial authority to select an alternative site and sponsor the tournament.
- 4. A WVCA Postal Championship shall be held every two years. The format will be decided by the Postal Director. This event should be USCF rated.
- 5. The WVCA shall conduct a seven (7) round G-30 Action Championship to be held between March 1 and July 1. The K factor is to be determined by the Tournament Director. The bid for the Action tournament is to be separate from that of the State Championship. Bids should be presented at the annual business meeting held before the State Championship. The Action Championship shall be advertised in a timely manner in Chess Life.

in a

- 6. The WVCA shall also conduct a G-10 Quick Chess Championship on Saturday or Sunday during the State Championship to be advertised in the WVCA Bulletin.
- 7. The WVCA shall also conduct a G-5 Blitz Chess Championship on Saturday or Sunday during the State Championship to be advertised in the Bulletin. This Championship will be run under the rules of the World Blitz Chess Association (WBCA). Players do not have to be members of the WBCA to participate in the Blitz Championship.
- 8. The Bidding Process for the right to host the State Championships will be held annually at the WVCA Business Meeting. Bids to host the Action Championship and the State Championship will be accepted separately. If there are multiple bids for an event, then the membership present will vote on the hosting site with a simple majority needed. In case of a tie, the current Moderator will break the tie. If possible, a backup site should also be obtained in case the winning bid cannot fulfill their award. If no bids are received, the Board of Directors will be tasked with finding an appropriate site for the Tournament.
- 9. The WVCA shall hold a Grand Prix Championship that will be based on performance over a year of events. The Grand Prix guidelines are as follows:
- a. Player Eligibility: Must be a current WVCA member. A person may purchase WVCA membership at the conclusion of a tournament and have the results of that event count. No points will be accrued for the period that a membership is elapsed. Members that are residents from other states are eligible for all prizes awarded.
- b. Tournament Eligibility:
 - 1. Must be open to all players. Tournaments with multiple sections (i.e. Open and U1600) that satisfy this rule are eligible. Club Championships and Invitations events are not eligible.
 - 2. Tournaments must be at advertised in Chess Life, the WVCA Bulletin and/or the WVCA Website at least one time.
 - 3. Tournaments must be at least four rounds.
 - 4. Time controls must be no faster than G/60. The only exception to this rule is the WV Action Championship. Tourney must be contested in WV with this exception: A WV chess club that holds a tourney in a adjacent state can get a waiver from the Grand Prix Coordinator, though not automatic. (Ex. Parkersburg club holds a tourney in Marietta, OH or Logan County Club in Belfry, KY).
 - 5. The Tournament Director must send official USCF Crosstables to the Grand Prix Coordinator.
 - 6. The tournament should require all West Virginia players to be WVCA members or have a surcharge (i.e. EF: \$20, \$5 discount for WVCA membership). Scholastic players may be exempted from this rule.
- c. Points distribution: Wins, Forced Bye, Forfeit Win 1 point;

Draw - 1/2 point; Loss, Forfeit Loss, Voluntary Bye - 0 points

d. Bonus point Distribution:

WV Action Chess: Winner and still champ, Donald Griffith

Donald Griffith continued his winning ways by capturing the 2000 West Virginia Action Championship. In the past year, he has won the West Virginia State Championship (shared with Mark Hathaway) and the Charleston Chess Club Championship. This was the third Action title for Donald in the five years this event has been held. Donald finished with five wins and two draws (Jerry Skeen and Markle Butcher) for a total of six. Jim Walker was second at 5½. The pivotal game was the Griffith-Walker contest occurring in round 3. This win ascended Donald into the lead, where he proceeded to beat all challengers until the final round, where the draw with Markle clinched the title. Jerry Skeen, Jim Fuller and Markle Butcher tied for third place, each ending the day with 4½ points.

U.S. Amateur Championship, South Regional, Games from Mark Hathaway by Mark Hathaway

Co-state champion Mark Hathaway ties for first at the 2000 US Amateur South with David Saville and Ruixin Yang. Mark was kind enough to send on his thoughts on some of his games. - TLB

White would fight for control of d5 and attempt to apply pressure, eventually, to Pd6. 8...O-O 9. f4 This newer approach allows for e5xf4 when White can recapture in one move with Bc1, rather than Rf1xf4. 9...exf4?! 9...b5 Possibly best is to pressure Pe4 by Bc8-b7. 10. Bxf4 Be6 11. Qe1 With Bf4 already bearing down on Pd6 it's only natural to place Qg3 and Rd1 to add more pressure. With Og3 White can also contemplate attacks at g7. - . . ? 11...Nc6 12. Qg3 Ne5 This blocks the direct threat and offers a pawn (perhaps poison). 13. Rad1 I briefly looked at Bxe5 and declined to become immersed in any complications related to that. I intended Ra1-e1-e3-h3, with Bd2 holding together the queen-side. 25...Qf7 26. Qg4 Rad8 After this move it appeared he might play d5-d4, taking away square e3 from my rook, so I changed directions a bit - trying to bring Ra1 into play another way. 27. a4 dxe4 28. Be3 Qc4 29. axb5 axb5 30. Rfe1 This very passive looking move seemed necessary to stem Black's counter-attack possibilities. I was worried I had misjudged the position, and that I might be losing. But, there were enough intangibles to make it unclear. 30...Ra8 A cautious move, but not unwarranted. 30...Qb3 is safe enough, but if Qb3xb2 then the queen is two moves from returning to defend Kh8. 31. Rad1 Rfd8 32. Qh5 Now that Black has ventured away from his purely defensive stance I can renew the threat of Bxh6!. 32...Rxd1 33. Rxd1 Rf8 34. h3 Qb3 35. Rd7 Kg8 36. Bg5 Draw agreed White is better here, but it's not so easy to win when both players are in time pressure. He had planned 41...Bf4 and I was considering 42. h4, preventing Bf4-c1 (or d2) and keeping Black's king at bay. If I could have forced a favorable bishop trade it would be a win. Unfortunately, I didn't have sufficient time to work out all the subtleties. This game came back to haunt me (in a way), as my opponent survived to tie for first (with David Saville and me) and then went on to beat me in the final tie-break speed chess games, to win the title.

Hopefully, we will see Mark in South Charleston over Labor Day weekend to try and defend his West Virginia State Title.

Ruixin Yang Outlasts Hathaway and Saville at the USAS; Ricky Durbin Reserve Champion

Ruixin Yang, a student from Arlington, Virginia was the winner of this year's United States Amateur Championship, Southern Regionals. The past winners of the USAS contested in Charleston were John Roush (WV) in 1997, William Surlow (PA) in 1998 and Russ Wilson (OH) last year.

After the five rounds of play, Ruixin, Mark Hathaway and David Saville were tied with a score of 4-1. They played a round-robin blitz series to break the ties. In the first game, Mark takes Ruixin's last pawn just before his flag fell - a draw. Then both Yang and Hathaway defeat Saville. Ruixin then defeated Mark in a best-of-three match to determine the champion. Class winners were Jeff McAleer (A) and West Virginian's Gary Morris (B) and Walt Rueckert (C).
